A teacher for 45 years, Edith raised generations of readers and writers (and arithmetic whizzes, too) but her contribution to the betterment of her community didn't stop there.

Bequeathing The KGH Foundation with a surprise gift of \$950,000 from her estate, Edith left a legacy of generosity that will benefit cardiac patients in the Interior for years to come.

After finishing her teacher training in Moose Jaw, Saskatchewan, Edith moved to B.C. in 1945, where she went on to complete a Master's degree in education. The majority of her career was spent at Richmond Senior Secondary School but shortly after retiring, she made her way to the sunny Okanagan.

Edith was a picture of health, enjoying an active life until she was 96, but sadly several of her family members suffered from cardiac issues, prompting her to support cardiac care at KGH.

The first open-heart surgery was performed at KGH on December 3, 2012. Since then over 300 patients from the Interior have benefitted from having local access to this life-saving procedure.

OUR CHIEF OF STAFF OWES HIS WORK – AND HIS LIFE – TO KGH

Dr. Mike Ertel is a recognizable face around Kelowna General Hospital. During his sixteen years of service he has worked as a full-time Emergency Room physician, Chief and Medical Director of the ER and Medical Director of Emergency Services for Interior Health. Like the chaos inherent of his specialty, he thrives on challenge and change, recently moving into administration as the hospital's new Chief of Staff.

Known for his sense of humor, beguiling smile – and slightly short stature – he's really larger than life, fiercely tenacious, awfully persuasive and a heck of a hockey player, too.

"I always wanted to be a doctor, even as a little kid. That or an NHL hockey player, but then I stopped growing," he says, grinning.

Lucky for his profession – and particularly KGH – medicine came first. Dr. Ertel always gives his all. "I'm kind of a workaholic," he admits.

What he never imagined is one day he'd end up in the ER for an entirely different reason. "When you're Chief of Staff you don't really anticipate being a patient."

On May 15, 2012, after completing a busy shift, Dr. Ertel went home – and had a heart attack.

"I didn't have any chest pain, no shortness of breath but pain in the right shoulder and stomach that wouldn't go away," he recalls.

The marathoner and fierce hockey forward listened to his instincts: something was wrong. "The little man on his shoulder" whispered to him to get back to the hospital – as a patient.

"I went in the back door because I didn't want to bother anyone. The ER nurse on shift just shook his head and when I looked at the ECG report, I thought, Oh boy. I'll be in the Cath (catheterization) Lab in an hour."

Being in the hospital bed – rather than beside it – renewed his appreciation of KGH and his colleagues.

"I was chief of the ER at the time," he explains, "But that had nothing to do with it. We have outstanding physicians and support staff. Patients here receive fast, excellent care. I had a stent inserted into a coronary artery (percutaneous transluminal coronary angioplasty). The procedure has been available at KGH for little more than a year but it was there when I needed it. Previously I'd have been flown to Vancouver, waiting up to a week. At KGH I was cared for and released within 48 hours."

"It is my hope – my personal mission – to provide this kind of care for everyone."

If saving lives is Dr. Ertel's calling, living his own with passionate appreciation is his duty. He relishes every moment with his three daughters (all competitive Nordic skiers) and wife and partner in profession, Dr. Wendy Wickstrom.

"I feel great now," he says. "I'm so grateful for my health and this hospital." ■

**THE FORMER FIRE CHIEF AND CURRENT CITY COUNCILOR
CREDITS FAMILY AND FRIENDS – INCLUDING THE STAFF
OF KGH – FOR HELPING HIM WIN SOME SERIOUS BATTLES**

In 2003 the Okanagan Mountain Forest Fire swept across the southeast hills of Kelowna, ravaging land and homes, but not the spirit of this stunning city – especially its then Fire Chief, Gerry Zimmermann.

Gerry's humility, honesty, optimism and fierce tenacity in the face of tragedy – qualities that helped him heal several years earlier, after losing his first wife, Lorraine, in a car crash – spurred the community to come together.

The same qualities would pull Gerry through a brush with death almost six years later.

The morning of April 29, 2009, Gerry headed out to the gym for his daily workout when suddenly he didn't feel well. "I thought I had the flu," he recalls. "I turned around and went home."

As the day progressed so did Gerry's symptoms. "I called my wife, Sandy. We headed to the hospital and I literally crashed through the doors of the ER and threw myself on a gurney."

The last thing Gerry remembers is crying out, "Somebody help me!" He woke up in the Intensive Care Unit two-and-a-half months later.

Following gallbladder surgery, a remaining gallstone had blocked one of Gerry's bile ducts, resulting in pancreatitis – a serious medical condition that occurs when the enzymes that digest food are activated in the pancreas rather than the small intestine.

Removing the stone can be the cure but when Gerry became septic, his family thought they would have to say their goodbyes.

"My kidneys shut down. I was on life support," he says, "Although I was in a coma, so I don't remember. Everyday they'd go in and cut a little of my pancreas away. When my blood pressure dropped, they'd stop. I had every intervention imaginable."

Friends and family, in fact much of Kelowna, rallied around the Chief who had led them through one of the worst natural disasters in Canadian history to win the fight of his life.

"I don't think I would've survived if I'd been somewhere else," he says. "Every single doctor and nurse (and there were a lot of them), to the lady who served me two cups of coffee every morning to get me going, to the one that washed my hospital room floor. I can barely put words to the wonderful care I received."

The same day Gerry crashed through the doors of the ER, his youngest granddaughter was born upstairs. Pictures of his grandchildren and dogs decorated the end of his bed.

One day, with 60 tubes snaking from his body, three nurses placed Gerry on a stretcher, loading his life-supporting equipment on an adjoining gurney.

"They took the whole entourage to a park behind the hospital where my dogs were waiting," he remembers, smiling.

Fully recovered three years later, Gerry says the only thing he can't do is slow down. Elected as a city councilor in 2011, he's sailed the Adriatic Sea, participated in 100 km bike rides and ski races. He recently put in another acre of vineyard. ■

He never guarantees clear skies but seasoned weather specialist, Mike Roberts, always comes to the camera with a sunny smile.

There's just something about the way he delivers the news, produces and portrays stories about the region's people, or shares insight to the province's rich history through his work with Bill Barlee on "Gold Trails and Ghost Towns," that keeps the public tuned in.

Friendly, reliable, and self-effacingly funny, Mike is an icon in the Okanagan, not only through his work in television, because of his commitment to the community. Central Okanagan United Way Honorary Chair since 1993, he's been acknowledged for his contributions with numerous notations, including the Queen's Diamond and Golden Jubilee Medal, the Governor General's Caring Canadian Award and the Anita Tozer Award for outstanding contributions to the community, among others.

A time for celebration and maybe a little sadness, Mike is marking forty years with Global Okanagan by handing over the microphone. "I couldn't bend over and kneel to tie my shoes," Mike says, recalling the state of his health prior to his surgery. "The doctors told me I had severe deterioration of the hip joints and I would need full hip replacements."

Mike's sons painted a more descriptive picture: "They said I ran like a quail," he laughs. "These two little legs moving without articulating at the hips."

Awed by his new mobility, Mike says he's doing things he hasn't been able to for many years. "Like crossing one leg over the other!"

Grateful for the expert care he received at Kelowna General Hospital, Mike sailed through surgery. "I got the left hip done first; the right one a year later. It was as easy as pie. I can honestly say hip replacements are remarkably pain free. I was a little weak and there was a little loss of muscle control but that comes back quickly. You just have to work on it."

Working hard comes naturally to Mike but he considers himself most blessed by the family he loves. Married for 44 years with three sons and daughters-in-law, he particularly relishes time with his six grandchildren.

"Kneeling down to hug my grandchildren," he says with a smile. "That's something I couldn't do before." ■

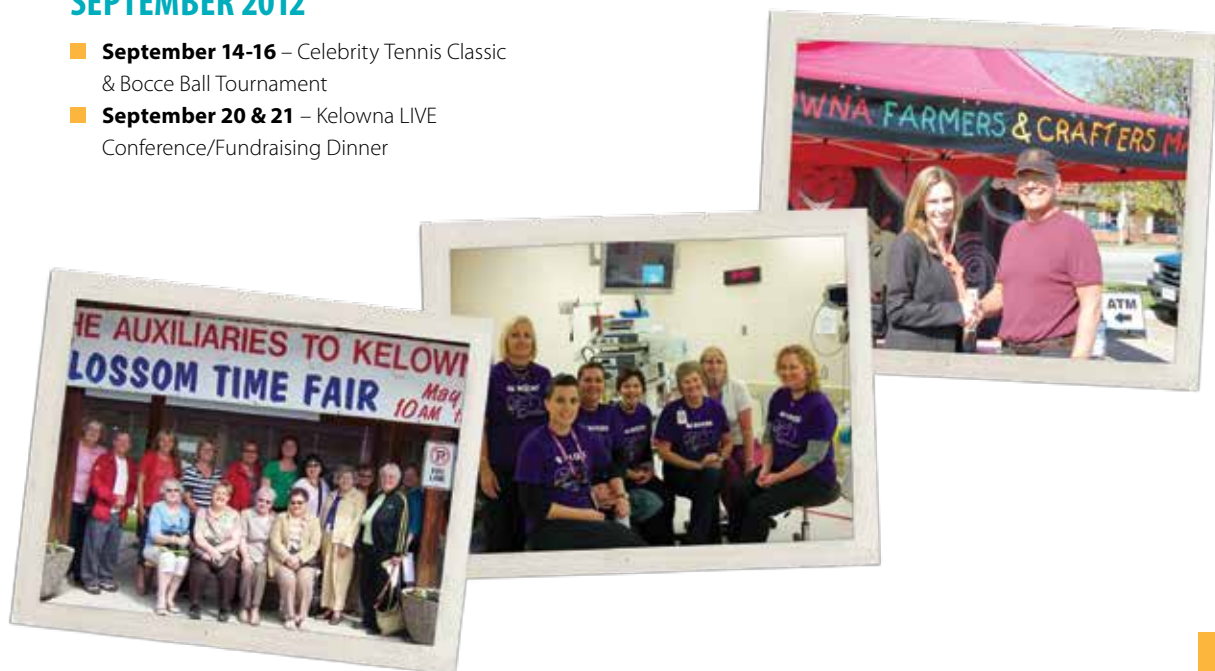

KELOWNA GENERAL HOSPITAL

The Hospital is a 377 bed tertiary teaching hospital. It is a regional trauma centre serviced by air ambulance. It contains a level 2B Neonatal Intensive Care Unit and provides a range of tertiary services available to 740,000 patients throughout Interior Health and across the north.

CENTRAL OKANAGAN HOSPICE HOUSE

Hospice House provides individuals who are dying and their families high-quality palliative care in a tranquil home-like setting to meet the patient's physical, emotional, and spiritual needs and make their last days peaceful, comfortable and meaningful.

COTTONWOODS EXTENDED CARE HOME

Cottonwoods Care Centre is a 213 bed residential care facility located on 11 acres in central Kelowna. The building also houses a Gerontology Centre, where geriatric patients are referred for consultation with an interdisciplinary team including an in-house geriatrician.

DAVID LLOYD JONES HOME

David Lloyd Jones Home is a residential Care Facility consisting of 3 adjoining wings totaling 64 private rooms. The resident-centred philosophy is designed to support residents' choices, help people function at their highest level and provide the best quality of life possible.

BROOKHAVEN CARE HOME

A personal care facility located in West Kelowna providing 84 beds for residential care. It also houses a specialized psychogeriatric secure environment providing 20 beds.

THREE LINKS MANOR

Three Links Manor is a two-level seniors care home with 80 residential beds. The facility embodies a resident-centred philosophy designed to support residents' choices, help people function at their highest level, and provide the best quality of life possible.

and clinical offices cater to our robust senior population, both as patients and visitors.

KGH continues to evolve as we embark upon the construction of the Interior Heart and Surgical Centre. This exciting development provides a complete redesign of surgical services and adds new clinical space to perform cardiac catheterizations and other perfusion services.

We are immensely proud of how far our hospital has come but added growth comes with added responsibility. We need to provide our medical staff with the best equipment possible. This is our task and the KGH Foundation is dedicated to making it happen.

Now and in the coming years we look forward to working with our community to enable us to meet this challenge. The caring generosity of our supporters helps create the best health care, right here in the Interior.

WHO WERE THEY THEN?

In the beginning a group of women had a vision to make their community stronger by assisting their hospital with the care and comfort of its patients. They were nurses, house wives, mothers, grandmothers, sisters, daughters...they sewed, and sewed, and sewed and their mandate was to supply linens for KGH. In early 1907 there were approximately 700 women in Kelowna and area. 20 of these amazing women began what were to become the Auxiliaries to the KGH Foundation. They raised funds to support the linen program with many creative projects and endured through hard times. From 1929 to 1976 the five Auxiliaries to KGH were formed and developed into the organizations they are today.

WHO ARE THEY NOW?

Today, we see the hospital auxiliaries still consisting of mothers, grandmothers and daughters but they have now opened their doors to grandfathers, fathers and sons. They welcome people of all ages, religions and cultural backgrounds and the age demographic ranges from 14 to 96. All with the same goal in mind... to volunteer and help change lives.

Some of the original look of the auxiliary still prevails and is respected and revered but the days of raising money for linens or nursing residence are over. The Auxiliaries have evolved and now run businesses that enable them to purchase equipment whose value is in the millions. They are running operations with revenue in the hundreds of thousands of dollars each year. Of course, to maintain the leadership roles and continue with their legacy, the Auxiliaries always encourage and welcome new members.

Volunteers no longer just sew (although the sewing that is still done is truly valued and needed), they help in many different ways. They are Interior Designers and Project Managers that have given countless hours of time toward projects. They are people that have back grounds in accounting and cash reconciliation and give their time to help manage the financial end of the businesses. They are people that have the knowledge to purchase inventory, manage inventory, arrange flowers, operate automated coffee machines, merchandise, market, write, take photos, operate software systems and POS systems, and so much more. ■
